STROUDSBURG BOROUGH COUNCIL MEETING MINUTES – MAY 6, 2025

A regular meeting of the Stroudsburg Borough Council convened at 7:00 p.m. in the Council Chambers of the Stroudsburg Borough Municipal Building with the following members present: Council Pro-Tem Joseph Shay, Council Member Victoria DeVries, Council Member J. Zac Christman, Council Member Cheryl Joubert, and Council Member TJ Lopez.

Also present were: Mayor Michael Moreno, Borough Manager Larry Kopp, Borough Solicitor Christopher Brown, Esq., Street Superintendent Brian Ace, Zoning/Codes Officer Kenelle DeStefano, and Executive Assistant Becky Smith. Council President Matt Abell, Council Vice-President Erica McCabe were absent.

The Pledge of Allegiance was recited.

Approval of Council Meeting Minutes for the Regular meeting on April 15, 2025

The minutes of the regular meeting on April 15, 2025 were approve, on a motion made by Mr. Christman, seconded by Mr. Lopez. The motion was carried. (yes-5; no-0; abstain-0)

New Business

Discussion about political signs in the Borough of Stroudsburg: It was confirmed that political signs are not allowed on private property without the property owner's permission, and would be considered trespassing if signs are placed on private property without owner's consent. Additionally, the current borough ordinance states "temporary signs shall not be located upon Borough, county, or state-owned property or within any public right-of-way". Ms. Joubert reported seeing signs be placed in yards sooner than they are allowed, and suggested information about the placement of political signs be added to the an upcoming newsletter. Mayor Moreno asked if the current ordinance could be posted on Facebook and the Borough's website. Ms. DeStefano said it would be helpful if the information was included in packets given by Monroe County Elections Office to anyone running for office. No action necessary.

A motion was made by Mr. Christman, seconded by Mr. Lopez to approve Mayor Michael Moreno as the Voting Delegate and Borough Manager Larry Kopp as Alternate Voting Delegate for the Borough of Stroudsburg at the 2025 Pennsylvania State Association of Boroughs Conference on June 4, 2025. The motion was carried. (yes-5; no-0; abstain-0)

Discussion about a potential Conservation Easement in South Stroudsburg: Solicitor Brown advised the Borough can create a Conservation Easement with the approval of all affected property owners, however it will not necessarily stop PennDOT's project. A conservation easement expressly allows eminent domain, and as the easement holder, the borough would receive "just compensation" if property is taken. Mr. Shay pointed out that the borough would be spending money on something that would not guarantee the PennDOT project to stop. Mr. Christman agrees that it would be a waste of money for something not beneficial. No action necessary.

A motion was made by Ms. Joubert, seconded by Mr. Christman to approve advertising for bids for the Downtown Streetscaping Mural Project. The motion was carried. (yes-5; no-0; abstain-0)

A motion was made by Mr. Lopez, seconded by Ms. DeVries to approve advertising for bids for five (5) Victorian style 7' transit shelters, two (2) Victorian style 10' transit shelters, and five (5)

6', anti-vagrant, freestanding benches, for the Downtown Streetscaping project. The motion was carried. (yes-5; no-0; abstain-0)

A motion was made by Mr. Christman, seconded by Ms. Joubert to approve the installation of 1,832 feet of Thermoform PVC Liner (slip lining) by Guyer Brothers, Inc., for \$149,974.00, COSTARS Contract 041-E22-016. This is slip lining for sanitary sewer lines on Bell Terrace, Scott Street between 8th and 9th Streets, North 6th Street, Lenox Street, and Barry Street. The motion was carried. (yes-5; no-0; abstain-0)

A motion was made by Mr. Christman, seconded by Ms. Joubert to approve a Resolution authorizing the submission of a Department of Community and Economic Development (DCED) Multimodal Transportation Fund (MTF) Grant for up to \$3 Million to the Commonwealth Finance Authority (CFA). Mr. Kopp explained the Borough is partnering with Brodhead Creek Regional Authority (BCRA) who will be replacing water mains that are in disrepair prior to borough paving projects. BRCA grant writers will be submitting the grant application. The motion was carried. (yes-5; no-0; abstain-0)

A motion was made by Mr. Christman, seconded by Mr. Lopez to approve the Special Event Application for the Trooper Joshua Miller Memorial 5K Run/Walk, on Saturday, June 7, 2025, from 8:00 a.m. to 11:00 a.m. The motion was carried. (yes-5; no-0; abstain-0)

A motion was made by Mr. Christman, seconded by Ms. DeVries to approve the Special Event Application for the Pocono PRIDE Festival on Sunday, June 1, 2025, from 12:00 p.m. to 5:00 p.m. Mr. Moreno stated there will be three stages set up, the Center Stage, Kids Stage, and Spotlight Stage, providing musical and drag entertainment from about 12:30 p.m. to 4:30 p.m. The Family Fun Zone expanded this year, and is a family-friendly PRIDE festival. Mr. Lopez asked how is "family-friendly" defined, to which Mr. Moreno explained the festival will not have vendors who sell alcohol, hemp, or "kink" items, and all programming is clean. Bollards are used at intersections surrounding the festival footprint. Mr. Lopez stated drag shows can be risqué, and asked if this year would be more appropriate for families. Mr. Moreno advised that previous years, with the exception of last year, all acts were on the Center Stage. This year, Rebel Stages is running the Kids Stage, creating an entertainment space appropriate for any age. Those who are looking for the true PRIDE experience can find entertainment, including drag shows, at the Center Stage. The Spotlight Stage is a more relaxed space. The motion was carried. (yes-4; no-0; abstain-1, Mr. Lopez)

A motion was made by Ms. Joubert, seconded by Mr. Christman to approve the request from the Pocono PRIDE Coalition to fly Progressive PRIDE flags throughout the month of June, in observance of PRIDE Month. Pocono PRIDE Coalition will provide flags and poles and a \$275 stipend towards Borough costs to hang the flags. The motion was carried. (yes-4; no-0; abstain-1, Mr. Lopez)

A motion was made by Mr. Christman, seconded by Ms. DeVries to approve the Special Event Application for the 4th Annual Irish American Festival on Saturday, September 6, 2025, from 11:00 a.m. to 8:00 p.m. The motion was carried. (yes-5; no-0; abstain-0)

The request from the Housing Authority of Monroe County for 30 discounted 2025 season passes to the Stroudsburg Pool was tabled. Mr. Kopp will contact the Housing Authority to clarify if the passes are given to tenants directly, or kept in the Housing Authority's possession to pass around to different families throughout the season.

A motion was made by Mr. Christman, seconded by Mr. Lopez to approve advertising for bids for the Parking Garage Repair Project. The motion was carried. (yes-5; no-0; abstain-0)

Committee Reports

Codes Committee – Mr. Moreno suggested the Codes Committee hold off on creating an ordinance regarding skill games, until representatives in Harrisburg vote on skill game regulations.

Budget Committee – No report.

Parking Committee – With regards to the parking issues on Friday afternoons near the Mosque on N. 2nd Street, Ms. Probst suggested Mayor Moreno reach out to Biospectra to inquire if they are willing to allow parking in their lot.

Street Committee – Mr. Moreno reported the committee reviewed traffic calming devices; Mr. Ace stated that other local municipalities do not have traffic devices that collect data. The next committee meeting is May 21, 2025, at 4:30 p.m. via Zoom. The committee will continue to seek traffic calming devices that collect data but do not display the speed at which vehicles travel.

Parks and Rec (Stroud Region Open Space and Recreation) Committee – Mr. Moreno reported the following fundraisers will take place to benefit SROSRC: Red Robin on May 15th; NEPA Gives, a 24-hour online fundraiser, on June 5th 7:00 p.m. through June 6th 7:00 p.m.; and Panera Bread on June 12th. The Levee Loop Trail Run will be held on June 7th. Mr. Moreno thanked Mr. Kopp for signing the Comprehensive Planning letter of support. Lastly, the ordinances relating to parks for East Stroudsburg Borough, Stroudsburg Borough, and Stroud Township were reviewed. The Working Committee will meet on June 9th at 5:30 p.m. to discuss further, and will provide a preliminary review of the draft ordinance for the June 24th SROSRC meeting.

Mayor's Report

Mayor Moreno attended the PSAB Your Role as a Municipal Secretary/Administrator on April 23 and 24 in Harrisburg. Mr. Moreno recognized Becky Smith, Executive Assistant, for her hard work at the Borough.

The Mayor read aloud a Proclamation, declaring May 9, 2025 as Miracles Happen Thrift Shoppe Day in Stroudsburg Borough. All are encouraged to attend the Miracles Happen Thrift Shoppe's grand opening at their new location, 14 N. 8th Street, on May 9th at 2:30 p.m.

The Stroudsburg Little Bethel Historical Association will be hosting its Annual Juneteenth Fish Fry Fundraiser on Saturday, June 21st, at which time Mr. Moreno hopes to tie in the street renaming event if the signage machine is available.

Quick Build / Main Street Project. Sent second request for Signage District to PennDOT on January 30th. Upgrades to the Borough's sign printer & laptop; should be delivered late April – early May. Called Labor & Industry in regard to Prevailing Wage requirements for project labor. Mural & Transit Shelter bids advertisement on agenda.

Creek Walk Trail. Statewide LSA Grant submitted November 26th. DCNR Grant submitted. DCED this year.

Parking Garage Repair/Rehabilitation. Design complete. Intent is to go out to bid for in May. LSA Grant award probably in May; CFA Meeting May 20th.

Levee Erosion Mitigation. Emplacing rip rap on the Brodhead Creek side of the levee to stop erosion. Working on plan from engineer; budget complete for DCED Flood Mitigation Grant. Work in 2026.
